All bidders on this project must comply with Federal Labor Standard Provision 29 CFR Part 5.5(a) and federal requirements of 2 CFR 200.321 under the set aside program defined in Chapter 348 of the City of Camden's Municipal Code

Bidders are advised the number of training positions will be 4, where feasible, consisting of at least 4 TRAINEES, TRAINEE HOURS =2,840 . (Per NJDOT Memorandum, Dated 3/5/18)

Specifications, Drawings, Contract Documents for the proposed work may be obtained at the Office of the Purchasing Agent, Room 213, City Hall, Sixth and Market Streets, Camden, New Jersey upon payment of fifty dollars (\$50.00). The payment for contract document(s) is nonrefundable.

A PRE-BID MEETING IS SCHEDULED FOR Tuesday, January 8, 2019 at 12:00 pm in City Council Chambers, 2<sup>nd</sup> Floor, City Hall, 520 Market Street, Camden, NJ 08101. ATTENDANCE IS STRONGLY RECOMMENDED. There is a non-refundable fee of fifty-dollars (\$50.00)

Each bid must be accompanied by Certified Check, Cashiers Check or Bid Bond to the order of the City of Camden, in the amount equal to ten percent (10%) of the sum of the bid but not in excess of \$20,000.00 together with a non-collusion affidavit. Proposals must be made on the standard Proposal Form, in the manner designated therein and required by the Specifications. Each Proposal must be enclosed in a sealed envelope bearing the name and address of the bidder and contract description on the outside, and addressed to: Purchasing Agent, City of Camden, City Hall, Room 105, Sixth and Market Streets, Camden, New Jersey.

The right to reject any and all bids or to accept the bid or any item of any kind deemed most advantageous to the City of Camden and to award contracts accordingly is expressly reserved to the authority of the City Council of the City of Camden.

**NOTE: All bidders are required to comply with N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et seq.**

The contractor is further notified that he must comply with P.L. 1977, c. 33, and submit a Disclosure Statement listing stockholders with his bid, P.L. 1963. C150 (New Jersey Prevailing Wage Act), and Americans with Disabilities Act of 1990 (42 U.S.C. 12101, et.seq.).

Bids will not be received after the time specified for the opening of the bids. Bids received after the hour appointed will be deemed invalid and returned unopened to the Bidder.
