| <p><b>African-American Advisory Board</b><br/>           Meetings: 4<sup>th</sup> Tuesday<br/> <i>Duties – make recommendation to City Council as to legislation and policy for the betterment of the African-American Community</i></p>  |
| <p><b>Arts, Cultural and Heritage Commission</b><br/>           Meetings: 3<sup>rd</sup> Tuesday<br/> <i>Duties – as an advisory board to the Mayor &amp; City Council assist &amp; recommend programming, public art and artist service including the plans for the development of city-wide programs</i></p>  |
| <p><b>Camden Redevelopment Agency (CRA)</b><br/>           Meetings: 1<sup>st</sup> &amp; 2<sup>nd</sup> Wednesdays<br/> <i>Duties – to focus on revitalization and development of areas with the City of Camden; improve and promote commercial districts fostering civic beauty and neighborhood pride</i></p>  |
| <p><b>Historic Preservation Commission</b><br/>           Meetings: 4<sup>th</sup> Thursday<br/> <i>Duties – to maintain and recommend historical sites or property within the City of Camden; review and approve any alterations or demolition of existing historical property</i></p>   |
| <p><b>Housing Authority Commission</b> *statutory<br/>           Meetings: 3<sup>rd</sup> Wednesday<br/> <i>Duties –pursuant to the Local Housing Authorities Law of the State of New Jersey, plan, design, construct, improve, manage, and maintain safe housing accommodations for the low income</i></p>   |
| <p><b>Parking Authority Commission</b> *statutory<br/>           Meetings: 4<sup>th</sup> Monday<br/> <i>Duties – to plan, design, construction, improve, manage, and maintain parking projects consider handicap parking applications; enforce street parking regulations; act pursuant to the provisions of the Parking Authority Law (N.J.S.A. 40:11A-1 et seq.)</i></p>                     |
| <p><b>Planning Board</b> *statutory<br/>           Meetings: 2<sup>nd</sup> Thursday<br/> <i>Duties – to review and approve development; prepare, revise, and recommend a comprehensive plan for the City; recommend changes, additions, or deletions to the Zoning Code and map and new ordinances pertaining to zoning as it appears advisable</i></p>  |
| <p><b>Shade Tree Commission</b><br/>           Meetings: 4<sup>th</sup> Wednesday<br/> <i>Duties – to regulate, plant, control, and care of trees and shrubbery in any public area; consider grants for assisting in shade tree projects</i></p>  |
| <p><b>Veterans Advisory Commission</b><br/>           Meetings: 3<sup>rd</sup> Thursday<br/> <i>Duties – make recommendation to City Council as to legislation and policy for the betterment of Camden’s Veterans; provide entitled resources and programs to the City; promote Veteran or military observations or recognitions; act as liaison with Veteran’s Fraternal Organizations</i></p> |
| <p><b>Zoning Board</b> *statutory<br/>           Meetings: 1<sup>st</sup> Monday<br/> <i>Duties – hear and decide appeals or requests for interpretations due to order, requirement, decision or refusal made by the Zoning Officer; grant variances to permit restrictions per the Zoning Code</i></p>   |
