

ORDINANCE OF THE CITY OF CAMDEN, COUNTY OF CAMDEN, STATE OF NEW JERSEY, RELEASING, EXTINGUISHING AND VACATING THE RIGHTS OF THE PUBLIC OF A PORTION OF CERTAIN PAPER STREETS KNOWN AS N 30TH STREET, POLK AVENUE, AND TYLER STREET, IN THE CITY OF CAMDEN, PURSUANT TO AND IN ACCORDANCE WITH N.J.S.A. 40:67-1 ET SEQ., AND RESERVING AN EASEMENT FOR ALL UTILITIES WHICH MAY CURRENTLY EXIST AT EACH AFORESAID PAPER STREET

WHEREAS, pursuant to N.J.S.A. 40:67-1.b and N.J.S.A. 40:67-19, the City Council of the City of Camden ("City") may, by ordinance, vacate any public street or portion thereof, dedicated to public use, but not accepted by the City, whether or not the same, or any part, has been actually opened or improved; and

WHEREAS, certain portions of N 30 Street, Polk Avenue, and Tyler Street, in the City of Camden, which are adjacent to real property owned by Camden County for use by the public as Von Neida Park, are all paper streets and remains unimproved; and

WHEREAS, the City desires to vacate certain portions of N 30 Street, Polk Avenue, and Tyler Street, in the City of Camden, in favor of County of Camden ("County") for the public purposes of the Von Neida Park Stormwater Management and Park Improvement Project ("Project"), a partnership of the City of Camden, Camden County, Cramer Hill Community Development Corporation, and Cooper's Ferry Partnership ("Cooper's Ferry"); and

WHEREAS, the Project is funded by the U.S. Environmental Protection Agency ("USEPA") and New Jersey Department of Environmental Protection ("NJDEP") Green Acres Program-- which Program requires Camden County's complete site control--and will mitigate flooding by constructing improvements to the underground drainage infrastructure, as well as developing a surface stormwater management strategy. Additionally, the Project will improve the quality and safety of the park by adding additional recreational amenities; and

WHEREAS, pursuant to the recommendation of the City Administration, it has been determined by the City Council of the City of Camden as follows:

1. That certain portions of N 30 Street, Polk Avenue, and Tyler Street, in the City of Camden described herein are not needed for public road purposes; and

2. for the reasons stated herein certain portions of N 30 Street, Polk Avenue, and Tyler Street hereinafter described have been determined by the City to be better utilized for public use as part of the adjacent County-owned Von Neida Park real property; thus, pursuant to N.J.S.A. 40:67-19, the City has found that the public would be better served by vacating, releasing, and extinguishing its rights and interests in and to the aforesaid portions of dedicated paper streets.

WHEREAS, the City shall follow the procedure set forth in N.J.S.A 40:49-6 to publicize, file public notice of its intention.

and hold a public hearing on the matter and that it is in the best interest of the general public and the City to vacate the aforesaid portions of dedicated paper streets; and

WHEREAS, pursuant to N.J.S.A. 40:67-1.b, the City Council must, by Ordinance, preserve the right of public utilities to maintain, repair and replace their existing utility facilities, including cable television facilities, in, adjacent to, over, or under the property or right-of-way to be vacated;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Camden, County of Camden, State of New Jersey, as follows:

SECTION 1. All public easements, right, and interests to certain portions of N 30 Street, Polk Avenue, and Tyler Street, in the City of Camden, as described herein are hereby vacated, released, and extinguished except for all rights and privileges now possessed by public utilities, as defined in N.J.S.A. 48:2-13, and by any Cable Television Company, as defined in the "Cable Television Act," N.J.S.A. 48:5A-1 et seq., to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, or any part thereof, to be vacated subject to the conditions described herein; all conditions, unless otherwise noted, shall be satisfied prior to said vacation being effective.

Description of the portions of N 30th Street, Polk Avenue, and Tyler Street, in the City of Camden:

A.Vacation of a Portion of N 30th Street in the City of Camden: Paper street portion of Public Right of Way for N 30th Street beginning at a point from the Northern curb line of Pierce Avenue in the City of Camden, running along the Northwestern paper lines of N 30th Street, and ending the Southern curb line of Harrison Avenue in the City of Camden. See attached map.

B.Vacation of a Portion of Polk Avenue: Paper street portion of Public Right of Way for Polk Avenue beginning at a point from the Eastern curb line of N 29th Street in the City of Camden, running along the Northeasterly paper lines of Polk Avenue, and ending at the Western paper line of N 30th Street in the City of Camden. See attached map.

C.Vacation of a Portion of Tyler Street: : Paper street portion of Public Right of Way for Tyler Street beginning at a point from the Eastern curb line of N 29th Street in the City of Camden, running along the Northeasterly paper lines of Tyler Street, and ending at the Western paper line of N 30th Street in the City of Camden. See attached map.

SECTION 2. The Municipal Clerk shall publish, this ordinance, after being introduced and having passed a first reading, at least once not less than ten (10) days instead of one (1) week prior to the time fixed for further consideration for final passage, pursuant to N.J.S.A. 40:49-6.

SECTION 3. The Municipal Clerk shall, at least one (1) week prior to the time fixed for final passage of such ordinance, mail a copy thereof, together with a notice of the introduction thereof, and the time and place when and where the ordinance will be further considered for final passage, to every person whose lands may be affected by the ordinance or any assessment which may be made in pursuance thereof, pursuant to N.J.S.A. 40:49-6, including, without limitation the County of Camden.

SECTION 4. The Municipal Clerk shall within sixty (60) days after such ordinance becomes effective file a certified copy of the ordinance vacating the herein described paper streets with the Office of the County Clerk in a special book set aside for dedications and vacations, pursuant to N.J.S.A. 40:67-21.

SECTION 5. The City Council does hereby authorize and direct the Mayor of the City of Camden and all other authorized City Officials to execute, on behalf of the City, all documents necessary to effectuate the vacation of lands contemplated herein.

SECTION 6. Any portion of this ordinance not herein amended and supplemented shall remain in full force and effect.

SECTION 7. All ordinances or parts or ordinances inconsistent with the provisions of this ordinance are hereby repealed as to such inconsistency only.

SECTION 8. This ordinance shall take effect twenty (20) days after final passage and publication as provided by law.

SECTION 7. If any provision of this ordinance is declared invalid, such invalidity shall not affect the other provisions of this ordinance. Furthermore, the other provisions of this ordinance are deemed to be severable and remain in full force and effect.

BE IT FURTHER ORDAINED, that pursuant to N.J.S.A. 52:27BBB-23 and N.J.S.A. 40:69A-41, a true copy of this Ordinance shall be forwarded to the Mayor, who shall have ten (10) days from the receipt thereof to approve or veto this Ordinance. Additionally, pursuant to N.J.S.A. 52:27BBB-23, a true copy of this Ordinance shall be forwarded to the State Commissioner of Community Affairs, who shall have ten (10) days from the receipt thereof to veto this Ordinance, and the action by the Commissioner regarding this Ordinance shall supersede any action by the Mayor on the same Ordinance. All notices of approval and/or veto shall be filed in the Office of the Municipal Clerk.


