Please note summary of Public Decorum rules below.

Rule XVII: Decorum

Any person who shall disturb the peace of the Council, make impertinent or slanderous remarks or conduct himself in a boisterous manner while addressing the Council shall be forthwith barred by the presiding officer from further audience before the Council, except that if the speaker shall submit to proper order under these rules, permission for him to continue may be granted by a majority vote of the Council.

City Council meetings shall be conducted in a courteous manner. Citizens and Council members will be allowed to state their positions in an atmosphere free of slander, threats of violence or the use of Council as a forum for politics. Sufficient warnings may be given by the Chair at any time during the remarks and, in the event that any individual shall violate the rules of decorum heretofore set forth, the Chairperson may then cut off comment or debate. At the discretion of the Chairperson, light signals may be used to display the commencement of the time for speaking and a warning light may be flashed to show that the appropriate time has passed. A red light will signal that there is no longer time.

ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 309 OF CITY CODE ENTITLED "IMPROVEMENT DISTRICTS" AND IMPLEMENTING THE CAMDEN BUSINESS IMPROVEMENT DISTRICT

WHEREAS, the City Council of the City of Camden adopted on September 10, 1992 Ordinance MC-2792, entitled, "An Ordinance Creating A Special Improvement District within The City of Camden and Designating a District Management Corporation by Submission of Said Ordinance to Public Referendum"; and

WHEREAS, on December 4, 2018 the City Council of the City of Camden adopted MC-5171 entitled "Ordinance Amending and Supplementing Ordinance MC-2792 to Amend the Boundaries of the Special Improvement District and Designate Camden Special Services District, Inc. (CSSD) as the District Management Corporation" which proposed the boundaries of the Camden Business Improvement District and designated Camden Special Services District, Inc. (CSSD) as the District Management Corporation; and

WHEREAS, MC-5171 authorized CSSD to take steps to define the scope of services appropriate for the proposed Camden Business Improvement District; review properties that may be subject to special assessment; consider exemptions; and develop a proposed budget; and

WHEREAS, CSSD in conjunction with a Steering Committee of community and business representatives has recommended to the Mayor and City Council that the creation and implementation of the Camden Business Improvement District will create a publicprivate partnership that will support the revitalization of several vital corridors within the City and foster continued economic growth; and

WHEREAS, the City Council of the City of Camden accepts the recommendations of CSSD and the Steering Committee; and

NOW THEREFORE, BE IT ORDAINED, by the City Council of the City of Camden that at least 10 days prior to the date fixed for public hearing thereon a copy of this proposed Ordinance and notice of the date, time and place of the public hearing shall be mailed to the owners of the lots or parcels of land included in the Camden Business Improvement District: and

BE IT FURTHER ORDAINED, that after review of the findings and recommendations of CSSD and the Steering Committee the City Council finds:

- The Downtown, Eds and Meds, Gateway and Waterfront corridors, as described by block and lot and by street address in Schedule "A" attached hereto and incorporated by reference would benefit from being designated as the Camden Business Improvement District ("CBID").
- 2) That the implementation of the CBID will create a public-private partnership that will continue the revitalization of these corridors and the City of Camden.
- 3) That it is in the best interests of the City of Camden and the public to create the CBID and to designate CSSD to continue as the District Management Corporation; except that CSSD shall not receive any funds or exercise any powers pursuant to the provisions of N.J.S.A. 40:56-65 et seq., unless the Board of Directors of CSSD shall include at least one member of the City Council of the City of Camden.
- 4) That upon implementation, a special assessment and/or fee shall be imposed and collected by the City of Camden with the regular property tax payment or payment in lieu of taxes or otherwise, and that all or a portion of the collected payments shall be transferred to CSSD, the District Management Corporation.

to effectuate the purposes of N.J.S.A. 40:56-65, et. seq. and to exercise the powers given to it by municipal ordinance.

BE IT FURTHER ORDAINED, that MC-2792 as codified in Chapter 309 of the Municipal Code of the City of Camden and MC-5171 are hereby amended as follows:

SECTION 1. Creation of District and Designation of Boundaries

- A) City Council of the City of Camden hereby creates and designates a Special Improvement District within the City of Camden to be known as the <u>Camden</u> <u>Business Improvement District</u> ("CBID") consisting of those properties as described by block and lot and street address in Schedule "A" attached hereto. The Camden Business Improvement District is comprised of the Downtown, Eds and Meds, Waterfront and the Gateway corridors.
- B) The following properties located within the boundaries of the CBID shall be subject to a special assessment:
 - 1) Class 1 Vacant Land;
 - 2) Class 4A Commercial assessed at or above \$400,000;
 - 3) Class 4B Industrial;
 - 4) Class 4C Apartments of Five or more units;
 - 5) Class 15D Tax Exempt properties assessed at or above \$10,000,000;
 - 6) Class 15F Tax Exempt properties assessed at or above \$1,000,000 and that are subject to an abatement/exemption agreement including but not limited to agreements governed by the "Economic Opportunity Act", <u>N.J.S.A.</u> 52:27D-489p, et seq. and the "Long Term Tax Exemption Law", <u>N.J.S.A.</u> 40A:20-1, et seq.
- C) For the purpose of implementing a special assessment, the property class shall be determined as of January 10 of each year, notwithstanding that property class may change during the year, and in accordance with any applicable laws and regulations.
- D) Class 2 Residential properties located within the CBID shall be exempt from any special assessment or fee.
- E) The assessed value of Class 4A, 4B, and 4C properties shall include any additional assessed value that would otherwise be excluded pursuant to a limited exemption including but not limited to exemptions governed by the "Economic Opportunity Act", N.J.S.A. 52:27D-489p, et seq.

SECTION 2. Assessments/Fee

- A) Operation and maintenance of the CBID. Annual operation and maintenance costs relating to services particular to the CBID, as distinguished from services normally provided by the City of Camden, will provide benefits primarily to the properties included within the CBID rather than to the City of Camden as an entirety. These annual costs shall be allocated to the benefited properties in the CBID by way of special assessment and/or fee pursuant to the provisions of this chapter and N.J.S.A. 40:56-65, et seq. In accordance with the applicable law and the provisions of this chapter the City shall only transfer to CSSD the special assessments and/or fees actually collected by the City.
- B) Development, construction or acquisition costs. All costs of development, construction and acquisition relating to improvements to the CBID shall be financed and assessed to properties especially benefited thereby. The City may, by separate ordinance or by amendment to this chapter, provide that improvements and facilities hereinafter acquired or developed shall be operated and maintained and the costs taxed to the benefited properties in the CBID.

SECTION 3. Designation of District Management Corporation

- A) City Council hereby designates the Camden Special Services District, Inc. ("CSSD") a non-profit corporation, as the District Management Corporation for the Camden Business Improvement District.
- B) The CSSD, in addition to acting in an advisory capacity to the Mayor and City Council, shall be governed by and also have all powers necessary and requisite to effectuate the purposes of this Ordinance and as specified in N.J.S.A. 40:56-65 et seq. as relate to the CBID, including but not limited to:
 - Adoption of by-laws for the regulation of its affairs and the conduct of its business and prescribe rules, regulations and policies for the performance of its functions and duties;
 - Prepare and administer annual budgets and funding requests for City Council approval;
 - Employ such persons as may be required and fix and pay their compensation from funds available to CSSD;
 - Apply for, accept, administer, and comply with requirements respecting an appropriation of funds or a gift, grant or donation of property or money;
 - 5) Make and execute agreements which may be necessary or convenient to the exercise of the power and function of the CSSD, including contracts and fee for service agreements, with any person, firm, corporation, government agency or entity;
 - Administer and manage its own funds and accounts and pay its own obligations;
 - 7) Borrow money from private lenders and government entities;
 - 8) Fund the improvement of exterior appearance of properties in the CBID through grants and loans;
 - 9) Enforce the conditions of any loan, grant, sale or lease made by the CBID;
 - 10) Provide Clean and Landscape Maintenance services in the CBID, supplemental to those normally supplied by the City of Camden;
 - 11) Undertake improvements designed to increase safety and attractiveness of the CBID to businesses which may locate there or visitors to the CBID, including but not limited to litter clean up and control, graffiti removal, handbills removal, landscaping, signage, parking areas and facilities, recreational and rest areas and facilities, and those improvements generally permitted under <u>N.J.S.A</u>. 40:56-65 et seq. and pursuant to pertinent regulations of the City;
 - Publicize, promote, and plan for the CBID and the businesses included within the CBID boundaries;
 - 13) Organize and assist with special events and activities in the CBID;
 - 14) Provide special parking plans and arrangements for the CBID;
 - 15) Provide temporary decorative improvements in the CBID;
 - 16) Act as a Destination Management Organization (DMO);
 - Recruit new businesses to fill vacancies in, and to balance the business mix of the CBID;
 - 18) Regulate vending to supplement activities supplied by the City of Camden;
 - 19) Design and enforce environmental and building design criteria to supplement activities supplied the City of Camden pursuant to applicable State and local law;
 - 20) Provide temporary decorative lighting in the CBID;
 - 21) Accept, purchase, rehabilitate, sell, lease, or manage property in the CBID in accordance with all applicable laws;

SECTION 4. Designation of Downtown Business Improvement Zone

A) City Council hereby designates the Camden Business Improvement District as a Downtown Business Improvement Zone in accordance with <u>N.J.S.A.</u> 40:56-71.2.

- B) CSSD, with the consent of City Council, may apply for loans under the State of New Jersey Downtown Business Improvement Zone Loan Fund. The Downtown Business Improvement Loan Fund shall be used for the purpose of undertaking public improvements to the CBID. In any instance in which the City of Camden or the CSSD receives a loan from the Downtown Business Improvement Loan Fund, the City of Camden shall establish assessments in the manner in which costs may be assessed pursuant to N.J.S.A. 40:56-71.5, et seq. within the CBID in which the Downtown Business Improvement Zone is located in an amount sufficient to produce revenues on an annual basis to repay the loan in accordance with the repayment schedule for the loan established by the Department of Community Affairs.
- C) All costs of development, construction, and acquisition related to improvements for the CBID shall be financed and assessed to properties especially benefited thereby.

SECTION 5. Board of Directors

- A) The Board of Directors of the District Management Corporation shall be comprised of thirteen (13) members. The Board shall consist of one (1) representative of City Council which shall be the City Council President or his designee, ten (10) members who are representatives of businesses or other entities in the Camden Business Improvement District, and two (2) Camden residents selected by the Mayor of the City of Camden. Any designee of City Council President shall be another member of City Council.
- B) The term of Board of Directors along with other rules and regulations governing CSSD shall be set forth in the adoption of its by-laws.

SECTION 6. City's Powers Retained

Notwithstanding the creation of the Camden Business Improvement District, the City expressly retains all its police powers and other rights and powers and authority over the area designated as the CBID.

SECTION 7. Inconsistent Ordinances

Any Ordinance or part of an Ordinance inconsistent with this Ordinance or any part of this chapter is hereby repealed as to the inconsistent provisions only.

SECTION 8. Severability

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate and distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 9. Remainder Full Force and Effect

Any portion of this Ordinance not herein amended and supplemented shall remain in full force and effect.

SECTION 10. Effective Date

This Ordinance shall take effect twenty. (20) days after final passage and publications as provided by law.

BE IT FURTHER ORDAINED, that pursuant to N.J.S.A. 52:27BBB-23 and N.J.S.A. 40:69A-41, a true copy of this Ordinance shall be forwarded to the Mayor, who shall have ten (10) days from the receipt thereof to approve or veto this Ordinance. Additionally, pursuant to N.J.S.A. 52:27BBB-23, a true copy of this Ordinance shall be

forwarded to the State Commissioner of the Department of Community Affairs, who shall have ten (10) days from the receipt thereof to veto this Ordinance, and the action by the Commissioner regarding this Ordinance shall supersede any action by the Mayor on the same Ordinance. All notices of approval and/or veto shall be filed in the Office of the Municipal Clerk.
