(the Americans with Disabilities Act). All bidders must comply with N.J.S.A. 52:25-24.2 (P.L. 1977, c.33) and submit a Disclosure Statement listing stockholders with their submitted bid. Successful bidder must provide a copy of their State of NJ Business Registration Certificate issued by the NJ Dept. of Treasury and completed Certificate of Insurance at execution of contract. No Bid may be withdrawn for a period of sixty days after the date set for the opening thereof.

The CSSD reserves the right to reject any or all Bids as provided for in the instructions to bidders or otherwise as applicable by law. Bids shall not include qualifying conditions or provisions. The CSSD reserves the right to consider Bid submissions for two weeks after receipt thereof, and further reserves the right to reject all Bids, waive informalities, and make such awards or act as may be in the best interest of the CSSD and in accordance with applicable law. The award of the contract for this bid shall be made pending approval and funding authorization in a lawful manner.
